

# Rental Agreement

Please read information listed below and sign to acknowledge your agreement and understanding.

1. **CHARGE FOR ADDITIONAL TIME**  
First 8 hours or part thereof 50% of rental fee. Over 8 hours (9-24) full day's rental.
2. **MISSING ITEMS**  
When items are supplied, missing ones will be charged for at the replacement cost.
3. **PETROL**  
There will be no refund of petrol. You should return the Vehicle with the same amount of petrol as was delivered to you.
4. **PUNCTURED TIRES**  
Renters are responsible for repair or replacement of punctured or damaged tires.
5. **UNAUTHORIZED DRIVER**  
No unauthorized driver should be allowed to drive your rented car. If you allow this to happen you **BREACH THE CONTRACT** and it becomes **NULL AND VOID**.
6. **CONDITION OF VEHICLE**  
You should inspect the rented Vehicle thoroughly and sign the appropriate form prior to accepting it.
7. **REFUNDS**  
Adjustments to your bill due to loss of use or authorized minor repairs will only be allowed if you notify our rental office at the time Vehicle was defective. Adjustments will only be made on presentation of valid invoice and written statement signed by the Renter.  
All body repairs and major mechanical must be approved by the company as a quality control measure.
8. **DAMAGE, THEFT OF VEHICLE OR PARTS AND ACCESSORIES**  
It is the responsibility of the Renter to protect the Vehicle after an accident. All accidents or thefts should be reported to us and the police immediately. You should obtain the name and address of the Owner and his/her Insurance company, and license number of any vehicle you may have collide with whether or not the Renter is at fault. Additional evidence such as independent witnesses and/or photographs at the scene of the accident could prove useful. The Renter is responsible for cost of repairs until the claim is settled.
9. The Agreement consists of all the terms and conditions on this page and the reverse side thereof. "Renters" refers to the person(s) signing the Agreement and any other person or organization to whom charges are billed by the Owner at the direction of the person signing, all of whom shall be jointly and severally liable hereunder. "Vehicle" means the automobile identified in this agreement, and all tires, tools, accessories and equipment attached thereto or contained therein.
10. The Vehicle is the property of the Owner. This is an agreement of rental only. It is expressly agreed that the Renter is not the Owner's agent servant or employee for any purpose, condition, or circumstances for, or in which the Vehicle is involved while operated by Renter.
11. Renter shall return Vehicle to Owner in the same condition received, except for normal wear, on the day specified in this Agreement or sooner if demanded by Owner. Renter is liable for full value of Vehicle and other charges that may result due to any neglect or carelessness on his/her part if vehicle is handed over to anyone other than Owner. Owner reserves the right to reposes Vehicle at any time, on demand, at Renter's expense if Vehicle is used in violation of the law, or is apparently abandoned. In the event of loss or damage and expense to Vehicle while on rental, whether or not it is the fault of the Renter, Renter shall pay to Owner on demand the amount of all resulting loss and expense to Owner. A refundable deposit will be collected from all Renters.
12. Renter shall pay owner on demand the sum total of all expenses for:
  - (a) Rental fees and applicable taxes.
  - (b) Shortfall in gasoline if Vehicle is returned with less gasoline than when rented.
  - (c) Service and wrecking charges in the event of an accident, if accident is Renter's fault and if not, until the claim is settled.

- (d) Spares, tools and accessories missing from vehicle, however lost or damaged.
  - (e) Damage to vehicle or property if Vehicle is not driven by Renter and involved in any accident or incident of any sort.
  - (f) Damage to Vehicle or property if rental period is expired and vehicle is not returned.
13. Vehicle shall NOT be used
- (a) To carry persons or property for hire (b) to propel or tow any vehicle, trailer or other object (c) in any race, test or contest.  
If Vehicle is obtained from Owner by fraud or misrepresentation, or is obtained or used in furtherance of illegal purpose, all use of Vehicle is WITHOUT OWNER'S PERMISSION.
14. Renter is responsible for and shall pay all parking and traffic violations, unless due to owner's fault.
15. No Right of Owner under this Agreement may be waived or modified except by written instrument signed by the Managing Director, a Director or Chairman of Vision Car Rentals & Tours Ltd.
16. This agreement shall be governed by the laws of Jamaica.
